## TERMS AND CONDITONS.

- Biding Documents will be available in the office of Executive Engineer PHE Division Dir Lower.
- BOQs/ instructions to bidders can be seen/obtain from the office of undersigned or downloaded from PHED
  web site (www.phedkp.gov.pk) upto last date of submission of tendes. Bids shall be submmitted electronically
  through E-Bidding not later than 23/07/2024 up to 11:00 AM, which will be open on the same day at 12:00
  Noon, in presence of Contractors or their authorized representatives who opt to be present.
- The quantities shown in the BOQ are only for the purpose of Tender and can be increase/decrease as per actual work done during the current financial year.
- As per KPRA Notification No. S.R.O(14).Vol:1-24/2021- 22 dated 10/05/2022 the Additional Security shall be submitted by the biders as under.
  - i) The contractors quoting their bids up to a limit of 10% below Engineer Estimate shall submit bid security at the rate of 2% only of Engineer Estimate.
  - ii) The contractors quoting their bids more than 10% below up to 20% below on Engineer's Estimate shall submit along with their bids 8% Additional Security of Engineer' Estimated cost in addition to 2% bid Security. If the bid is not accompanied with the required amount of additional security then it will be considered is non responcive and the 2% bid Security shal be

- forfeited in favor of Government and the second lowest bid and so on will be considered accordingly.
- Similarly, a Contractor quoting bid more than 20% below shall submit with his bid an additional Security on Engineer's Estimated cost equal to the differential amount of submitted bid and Engineer's estimate along with detail rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and/or required amount of additional Security, then the said bid shall be considered is non responsive.
- iv) In case detailed rate analysis submitted with the bids is, in view of the procurement not convincing, their Head of the Procuring Entity may be clear such bid as non responsive with out any forfeiture of bid Securities and record reasons thereof.
- v) The procuring Entities may offer the contract to next lowest bidder after due diligence the context of financial difference between such two bids are may advertised procurement of opportunity afresh.
- vi) The additional Security shall be released to the contractor in four installments i.e. 1st installment of 25% to be released upon completion of 25% of the project, 2nd installment of 25% to be released upon completion of 50% of the project, 3rd installment of 25% to be released upon completion of 75% of the project and the 4th installment of 25% to be released after 100% completion of the project.
- 5. The Earnest money and additional Security of 2<sup>nd</sup> and 3<sup>rd</sup> lowest bidder shall be released after approval of the lowest bid/tender by competent authority.
- 6. For the work mechanical/electrical firm/contractor must be registered (and have renewal) for the year 2024-25 with electric inspector Khyber Pukhtunkhwa. The contractor shall obtain local electrical/mechanical workshop (registered on the firm name) Certificate duly verified by SDO/ Sub Engineer incharge of this office before the opening date. The certificate must be attached with the bid documents.
- 7. Bid shall accompanied with 0.03% of estimated cost as tendered for fee in shape of separate CDR which is nonrefundable.
- 8. All Taxes are provincial/Federal Govt: will be deducted as per rules.

9. All other terms and condition will remain intact as per guidelines and Rules framed by Provincial Government.
