- The received bid (s) shall be evaluated as per the criteria mentioned in the solicitation documents.
- The content of technical and financial bids, uploaded by the bidder on EPADS, shall be readable.
- The date and time for the opening of the financial bid shall be announced after evaluation of technical bids.
- The bidder shall submit the sealed bid with requisite documents, including 2% Bid Security (or additional security if required of the estimated cost in the shape of a call deposit (original) before the closing date and time.
- Bidders shall submit a tender form fee (non-refundable), i.e., @ 0.03% for each work separately in the shape of a call deposit receipt (CDR) to the Executive Engineer, PHE Division, Nowshera.
- The bidders should submit their bid security as per KP-PPRA Notification No. SRO (14)/Vol: I-24/2021-22/6058-71 dated Peshawar, 10/05/2022.
