## TERMS & CONDITIONS.

BOQ to bidders can be seen / obtained from the office of undersigned or downloaded from PHE Department website www.phedkp.gov.pk up to the opening date of tenders.

2. Last date & time of submission of bid is 01/02/2024, at 12:00 Noon, which will be opened on the same date at 02:00 P.M in the presence of government contractor or their authorized representatives.

3. Bid Solicitation Documents / instruction to Bidders can be obtained from the office on any working day before the submission date & time.

- 4. As per KPPRA notification No. SRO (14)/Vol:1-24/2021-22 dated 10-05-2022 the Additional Security shall be submitted by the bidders as under:
  - (i). The contractors quoting their bids up to a limit of 10% below Engineer estimate shall submit bid security @2% only of Engineer Estimate.
  - (ii). The contractors quoting their bids more than 10% below upto 20% below on Engineers' Estimate shall submit along with their bids 8% Additional Security of Engineer' Estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security then it will be considered as non-responsive and the 2% bid security shall be forfeited in favor of Government and the second lowest bidder and so on will be considered accordingly.
  - (iii). Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer's Estimated cost equal to the differential amount of submitted bid and Engineer's Estimate along with detailed rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favor of Government and the 2<sup>nd</sup> lowest bidder and so on will be considered accordingly.
  - (iv). In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
  - (v). The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurement opportunity afresh.
  - (vi). After commencements of work by the successful bidder, the procuring entity may replace the Additional Security with a bank guarantee of the same amount from the scheduled bank; if the already deposited security is not in the form of bank guarantee.
  - (vii). The Additional Security shall be released to the contractor in four installments i.e. 1st installment of 25% to be released upon completion of 25% of the project, 2nd installment of 25% to be released upon completion of 50% of the project, 3rd installment of 25% to be released upon completion of 75% of the project and the 4th installment of 25% to be released after 100% completion of the project.
  - Bid shall accompany with 0.03% of E/Cost as Tender Form Fee in shape of separate CDR which is non-refundable, if not accompanied then it will be considered as non-responsive.
  - 6. All others terms and conditions will remain intact as per guidelines and rules framed by Provincial Government.
  - 7. The Bid Security @2% & Additional Bid Security of the 1st 2nd & 3rd bidder will be retained till approval of the tender.
  - 8. The procuring entity can reject any or all the works before approval as per rules.
  - 9. All taxes of Provincial / Federal Government will be deducted as per rules.
