

Public Health Engineering Division Hangu intends to invite Technical and Financial proposals from the Eligible firms on single stage two envelops system based on EPADs for supply, installation, testing and commissioning of the solar based (Pumping Machinery) to be installed under the following programs.

Schemes details, Technical Specification and the design parameters of solar based Pressure pump (pumping machinery) for the water supply schemes are given in the bidding documents. Bidders may obtain bidding documents and further information from the office of the Executive Engineer PHE Division Hangu on any working day before the closing date. The same can be downloaded from EPADs.

- 1. Technical Design should be based on technical aspects, hydraulic parameters of the scheme provided in the technical documents and rates should be quoted accordingly in the financial bid.
- 2. Tender form/BOQ can be downloaded after publication in newspaper/ Authority website or from Public Health Engineering Department website (www.phedkp.gov.pk) only by the per-Qualified firms/contractors.
- 3. The contractors quoting their bids up to 10% below Engineer Estimate shall submit bid security 2% on Engineer Estimate. Additional security shall be required as per KPPRA Notification No. SRO (14)/Vol:1-24/2021-22 dated 10-05-2022/6058-71.
- 4. Both (Technical + Financial) i.e., financial bid and technical bid separately sealed in envelops should be submitted through Registered Mail/Couriers service/Through special messenger to the office of the Executive Engineer PHE Division Hangu up to 12:00 pm on or before the closing date. Technical Bid will be opened at 12:30 pm on the same day respectively by the bid's evaluation/procurement committee in the office of the undersigned and in the presence of bidders or their representative opted to attend. Date of financial bids will be intimated to the qualified bidders accordingly.
- 5. Bidders may obtain bidding documents at a fee of Rs: 1000/- as per Govt: Rules payable through demand draft or pay order (Non-Refundable) in the name of Executive Engineer PHE Division Hangu.
- 6. Firms/Contractor must be registered with KPRA (Active Tax Payer).
- 7. All other KPPRA/Government of Khyber Pakhtunkhwa bidding/tendering rules will be applicable.
