- 2. Last date & time for submission of the bid is 11-07-2023 at 12:00 (Noon) which will be opened on same date at 2:00 pm in the office of the undersigned.
- 3. As per KPRA regulation No. S.R.O(14).Vol:1-24/2021- 22 dated 10/05/2022 the contractors quoting their bids more than 10% below upto 20% below on Engineers' estimate shall submit along with their bids 8% Additional Bid Security of Engineer estimated cost accompanying 2% bid security. Similarly, a contractor quoting bid more than 20% below shall submit additional bid security equal to the differential amount of submitted bid and Engineers' estimate along with detailed rate analysis with bid].
