NOTICE INVITING TENDER THROUGH EPADS

The Government of Khyber Pakhtunkhwa has received financial assistance (Loan) from the Kingdom of Saudi Arabia through the Saudi Fund for Development (SFD) to partially finance the Gravity Flow Water Supply Scheme, Mansehra. The Project is being implemented through the Project Management Unit (PMU), Public Health Engineering Department (PHED), Government of Khyber Pakhtunkhwa.

The Project Management Unit (PMU) Gravity Flow Water Supply Scheme Mansehra, PHE Department, Government of Khyber Pakhtunkhwa, invites sealed bids for the following works from Joint Ventures comprising **at least one Saudi Company and one Pakistani Company**.

1. The Saudi Company shall be classified as Class-A in the Kingdom of Saudi Arabia, shall possess valid registration and shall be eligible to undertake the subject works.
2. The Pakistani Company shall possess a valid Pakistan Engineering Council (PEC) License and shall meet the qualification and eligibility requirements specified in the Bidding Documents.
3. A Joint Venture Agreement shall be submitted with the Bid. All Joint Venture partners shall be jointly and severally liable for execution of the Contract.
4. The procurement process will be conducted through International Competitive Bidding using the Single-Stage Two-Envelope Method, in accordance with the Saudi Fund for Development (SFD) Procurement Guidelines. In the event of any procedural conflict between local regulations and the donor requirements, the SFD Procurement Guidelines shall prevail.

5. A complete set of Bidding Documents may be downloaded from EPADS (E-Pak Acquisition and Disposal System). Foreign firms may request assistance regarding access to Bidding Documents through the email address provided above.
6. Technical and Financial Bids shall be submitted electronically through EPADS. In addition, hard copies comprising one (01) Original and one (01) Copy of the Technical Bid and one (01) Original of the Financial Bid, in separate sealed envelopes clearly marked “Technical Bid” and “Financial Bid”, shall be submitted to the undersigned on or before **18th August 2026 at 11:00 AM (PST)**. Submission through EPADS and submission of the prescribed hard copies before the submission deadline are both mandatory requirements. Failure to comply with either requirement shall render the bid non-responsive.
7. Technical Bids shall be opened at **11:30 AM (PST)** on the same day in the presence of bidders or their authorized representatives who choose to attend. Financial Bids of only those bidders declared technically responsive and qualified shall be opened at a date and time to be notified by the Employer.
8. In case of any discrepancy between the electronic submission through EPADS and the hard copies, the electronically submitted bid shall prevail.
9. Bidders shall quote their bid prices as a percentage above or below the Engineer's Estimate in accordance with the requirements specified in the bidding documents.
10. Bid Security, Additional Security and rate analysis requirements shall be governed by the bidding documents, SFD Procurement Guidelines and applicable KPPRA requirements. All bids must be accompanied by a Bid Security (including Stamp Duty) and, where applicable, an Additional Security and a detailed rate analysis in accordance with the bidding documents and applicable procurement provisions.
11. Bidders shall submit a separate non-refundable Bidding Entry Fee at the rate specified above in the manner prescribed in the bidding documents.
12. Bid Security and Additional Security shall be provided in the form of a Call Deposit Receipt (CDR) issued by a scheduled bank operating in Pakistan from the bidder's own account in favour of the Project Director, Gravity Flow Water Supply Scheme, Mansehra. The original CDR shall be placed in the Financial Bid and shall also be scanned and uploaded to the EPADS. An affidavit confirming placement of the original Bid Security, Additional Security (where applicable) and Rate Analysis (where applicable) in the Financial Bid shall be included in the Technical Bid. Failure to provide the required original instruments and supporting documents shall render the bid non-responsive and may result in action under applicable procurement rules.
13. The bids shall remain valid for the period specified in the bidding documents.
14. A pre-bid meeting will be held on **07th July 2026 at 11:00 AM (PST)** in the Office of the Project Director, PMU, Gravity Flow Water Supply Scheme, PHED Pakhwal Chowk, Mansehra, Khyber Pakhtunkhwa, Pakistan. Foreign bidders may request virtual participation through the email address provided above.
15. The Employer reserves the right to reject any or all bids in accordance with the SFD Procurement Guidelines, bidding documents and applicable procurement provisions, assigning reasons thereof.
16. The bidding process shall be conducted in the English language. All bids, correspondence and

supporting documents shall be submitted in the English language.

17. The Employer shall not be responsible for any costs or expenses incurred by bidders in connection with the preparation or submission of bids, participation in meetings, site visits or any other procurement related activities.
